<p>On 4/17/22, Ofc. Brown responded the red phone in reference to a strangulation that occurred in June of 2021 in the Sportsman's Club parking lot. When I arrived I made contact with the caller, [REDACTED] stated that on June 6, 2021 she and a friend went to the Sportsman's Club for a birthday party. When she got there she saw her on and off again boyfriend Rayshaun Gravely.</p> <p>She stated near the end of the night she was talking to another male friend in front of the building. According to her, Gravely noticed this and became irate with her for speaking with another male. She stated that they walked across the</p>

parking lot arguing with each other. She then stated that Gravely then grabbed her right arm and twisted it behind her back. He then started pushing her through the parking lot until she was up against his vehicle. She stated that once she was up against his car he put his hand around her throat and began to choke her. She stated that she felt like he was going to kill her and that she was on the verge of going unconscious. She stated that she then reached up and began to scratch at his throat in an effort to get him off of her. He then released her and they proceeded to go back home together.

She stated that at the time she just put it off because she thought it would get better. But yesterday another incident occurred in Charlotte, North Carolina. Where Gravely was arrested for Domestic Assault on her and held without bond. She was issued a protective order in NC and tried to get one in VA but the Magistrate sent her to the police department to make a report for the strangulation.

She was able to provide pictures of the bruising on her neck from the incident, with the date and time on the photo matching her story. She also provided a picture of his neck where she scratched him trying to get him off of her.

She also provide a witness, [REDACTED], spoke with [REDACTED] who stated that Gravely did assault her that night in the parking lot but by the time she got over to them they had already split apart. She stated that she did observe Gravely pushing [REDACTED] against a vehicle though she could not tell where his hands were at the time. She stated she did notice that [REDACTED] was almost off of her feet with the tips of her toes barely touching the ground like he was holding her up.

Gravely at the time of the incident was employed by the Henry County Sheriff's Office (HCSO) and now both victim and suspect are employed by the HCSO. I then notified Lt. J.B. Lovell #208 that this incident was involving two current HCSO deputies. Lt. Lovell responded and also contacted the on-duty HCSO road supervisor Sgt. J. Kendrick who also responded and both spoke with the victim at the red phone.

I obtained a warrant for Gravely charging him with one count of strangulation. The warrant was sent to the Charlotte -Mecklenburg PD.
